Pursuant to the request made by the General Secretary, Indian Hotel and Restaurant Association regarding permission to Permit rooms, Vegetarian Hotels, Restaurants, Orchestra Bars to keep their establishments and License Rooms (Permit Rooms) open for more time on New Year's Day, it is hereby informed that with the remote permission of the Licensing Authorities, the above establishments are allowed to open regularly only for the period indicated below. Continuation beyond time is allowed.

The above-mentioned establishments should be allowed to open the establishment beyond the regular hours subject to the following conditions.

(a) The establishment holder shall ensure that no law-and-order problem arises in the said place by deploying private security guards in abundance inside and outside the establishment.

(b) In case of any misbehaviour/crime inside or outside the establishment and thereby creating a law-and-order problem, the sole responsibility of the establishment holder will remain. Accordingly, the establishment holder / licensee will continue to be eligible for action.

(c) Relaxation in respect of time shall not be objectionable to permit of premises, but the establishment shall be bound to comply with the provisions of the Noise Act.

(d) Extension of time as above shall be allowed only for establishments in enclosed premises / buildings."

(e) The Licensing Authority concerned reserves the right to refuse relaxation of the above time limit as and when deemed fit considering public peace and law and order.

Also, if the above-mentioned licensees request to extend the period of public entertainment license for the above period as the hotel/restaurant is allowed to serve liquor, the license authority should extend the period of the said license as above. However, while doing so, the Noise Pollution (Regulation and Control) Rules, 2000 and as per the directions given by the Hon Supreme Court, caution should be taken regarding the use of loudspeakers and loudspeaker systems. The Licensing Authority may refuse the relaxation of time limit as above if it deems fit considering public peace and law and order. Also, instructions should be given to all the concerned about keeping very good security everywhere.
