Whereas, Government of Maharashtra Public Health Department vide its order dated 2nd August 2021 as referred Sr. No. 8 directed about some modification to existing restrictions imposed vide order dated 4th June 2021 & 17th June 2021, which are applicable to Nagpur City also as Nagpur District not being covered under the list of 14 districts as mentioned in the said order of 2nd August 2021 & accordingly this office has issued order as referred at Sr. No. 9.

Whereas, the positivity rate of Covid-19 in Nagpur City has reduced to satisfactory extent and also there is ample availability of beds for Covid-19/Mucormycosis patients, it is felt necessary to allow some relaxations in existing restrictions.

Therefore in exercise of the powers conferred under relevant sections of the Epidemic disease act 1897 & The Disaster Management act 2005 & also other relevant law / Rules I, Radhakrishnan B. in the capacity of Commissioner Nagpur Municipal Corporation hereby directs to implement restrictions / directions in the city of Nagpur to various activities, as below:-

It is also directed that, this order will come into force from dt. 9th August 2021 & will remain in force till further order.

Note:-

- "Regular" means normal ways of transaction with Covid Appropriate Behaviour restrictions and subject to any SOP that may be promulgated by State Disaster Management Authority for various activities.
- 2. All other activities/conditions other than the ones specified in this order will be in accordance with the pervious orders issued earlier by this office and orders under reference.

- 3. All the Shop/Malls operators shall ensure about the vaccination of their staff as per the directions of Government of India. Further the customers entering the malls be insisted for their vaccination.
- 4. If any person / establishment doesn't follow the Covid Appropriate Behavior (Wearing of Mask, Maintaining Social Distancing, etc) properly or doesn't adhere to the directions/guidelines mentioned in this order, will be liable for strict punishments under Disaster Management Act 2005, Epidemic Diseases Act 1897 and section 188 of IPC 1860. Fines and Penalties will be imposed on the defaulters as per the orders mentioned in references. Offender's licenses or permissions of establishments will be withdrawn for operations till notification for Covid-19 epidemic, remains in force.
