The Executive Committee had appointed me as Scrutinizer to scrutinize the E-voting process together and also for the Voting conducted at the 71st AGM of the Association held on September 22, 2021.

The E-voting was held between on **Saturday**, **18**th **September**, **2021** (9:00 am) and **Tuesday**, **21**st **September**, **2021** (5:00 pm. The members of the Association as on "cutoff" date i.e. 15th September, 2021 were entitled to vote on the resolutions as set out in the notice to the Annual General Meeting (AGM) of the members of the Association.
